Adogo Privacy Policy

Adogo is committed to safeguarding & preserving the privacy of our visitors and each individual registered driver. The following explains what happens to any personal data that you provide to us, or that Adogo collect from you whilst you visit our site.

Information Adogo Collect

In running & maintaining Adogo's website, Adogo may collect & process the following data about you (visitor):

- Information about your usage behaviour on our site including details of your visits such as pages viewed. Such information includes traffic data, location data & other communication data as collected by the third party analytics tools that Adogo use on the website.
- Information provided voluntarily by you. For example, registration as a driver, advertiser or consumer.
- Information that you provide when you communicate with us by any means.

Usage of Cookies

Cookies provide information specific to the computer or mobile devices accessing a particular website. Adogo may use cookies where & when appropriate. Adogo may gather information about your usage on our website using cookies. Where used, these cookies are downloaded to and stored in your computer or mobile devices. Such information will not identify you personally. You can adjust your browser settings to reject cookies. This can easily be done in the privacy settings menu of your web browser.

Usage of Information

Adogo uses the information that are collected from you to provide our services to you. In order to conduct our business operations more smoothly, Adogo may use the information for one or more of the following purposes:

- To provide information that you requested from us relating to our products or services.

- To provide information relating to other products that may be of interest to you. Such additional information will only be provided where you have consented to receive.
- To inform you of any changes to our website, services or goods & products as well as information about advertisers who have expressed an interest in advertising on cars belonging to our members.

We may also be disclosing the personal data you have provided to us to our third party service providers, agents and/or our affiliates or related corporations, and/or other third parties whether sited in Singapore or outside of Singapore, for one or more of the above-stated Purposes. Such third party service providers, agents and/or affiliates or related corporations and/or other third parties would be processing your personal data either on our behalf or otherwise, for one or more of the above-stated Purposes.

Where your consent has been provided in advance, Adogo may allow selected third parties to use your data to enable them to provide you with information regarding unrelated goods & services which Adogo believe may interest you. Where such consent has been provided it can be withdrawn by you at any time.

Storing Personal Data

Upon operating our website there may be a need to transfer data that Adogo collected from you to locations outside of Singapore for processing & storage purposes. By providing your personal data to us, you agree to the transfer, storing or processing of your data in this way. Adogo take precautions and safety measures to ensure that your data is treated & stored securely. The sending of information via the internet is not totally secure & on such occasion information can be intercepted. Adogo cannot guarantee the security of data that you choose to send us electronically, sending such information is entirely at your own risk.

Disclosure of Information

Adogo will not disclose your personal information to any other party other than in accordance with this Privacy Policy & in the circumstances detailed below:

- In the event that Adogo sell any or all of our business to the buyer.
- Where Adogo are legally required by law to disclose your personal information.
- To further fraud protection & reduce the risk of fraud.
